The Charter of Organization And Operation of Phu Nhuan Jewelry Joint Stock Company, Internal Regulations on Corporate Governance, and Operating Regulations of the Board of Directors ("BOD") of Phu Nhuan Jewelry Joint Stock Company were endorsed by the 2023 Annual General Meeting of Shareholders ("AGM") on April 27th, 2023.
