- 4. Number of shares expected to be issued: 3,243,890 shares, equivalent to 0.96% of the total number of outstanding shares.
- 5. Transfer restriction period:
 - 100% of the number of shares are subject to transfer restrictions for 12 months, 70% of the number of shares are subject to transfer restrictions for 24 months, and 40% of the number of shares are subject to transfer restrictions for 36 months from the completion date of the issuance.
 - All additional shares issued by the Company to pay dividends in shares and/or bonus shares from equity/treasury shares that the participants receive arising from the number of ESOP shares in 2025 that are under transfer restrictions, will also be subject to transfer restrictions at the same rate and duration as the 2025 ESOP shares that are under transfer restrictions.
